

## **NOMINATION NOTICE:**

Invitation to members to nominate candidates for purposes of electing Trustees to the Board of Trustees of Medimed Medical Scheme

Dear Medimed member,

Medimed Medical Scheme is, as required by the Medical Schemes Act, managed by a Board of Trustees. In terms of section 18.2 of the Medimed Scheme Rules, at least half of the Board of Trustees, must be elected by members to serve terms of office of three years each.

The election of the member elected trustees for the next 3-year period will be held at the Annual General Meeting on 14 June 2019.

In terms of section 18.7 of the Medimed Scheme Rules:

"Nominations to fill vacancies, signed by a proposer and seconder in good standing with the Scheme, must be signed by the candidate signifying his/her consent to stand for election and must be submitted to the Scheme together with a current curriculum vitae ... and the election must be carried out by the members present at the annual general meeting of the Scheme."

You are hereby invited to nominate candidates to stand for election to the Board of Trustees and are directed to the Candidate Nomination Form enclosed herewith, together with the rules for the completion of the Candidate Nomination Form. The Candidate Nomination Form must be completed fully and properly to ensure that the nomination can be considered.

Completed Candidate Nomination Forms are required to reach the Administrator by no later than **16h30 on 23 May 2019**. Nominations which have not been submitted by the stipulated deadline will automatically be disqualified.

# CANDIDATE NOMINATION FORM OF MEDIMED MEDICAL SCEME RULES FOR COMPLETION OF THE CANDIDATE NOMINATION FORM

Member: Principal Member of the Scheme not dependants

**Scheme: Medimed Medical Scheme** 

- Only Members in good standing with the Scheme may nominate other Members as candidates.
- Only Members in good standing with the Scheme are eligible to stand as candidates for election.
- 3. A Member may only nominate one candidate.
- 4. Nominations must be submitted using the original enclosed Candidate Nomination Form.
- 5. Only original and signed Candidate Nomination Forms will be considered. No copies, faxed or emailed documents will be accepted.
- 6. Each Candidate Nomination Form must be signed by a proposer and a seconder, of whom both must be Members in good standing with the Scheme.
- 7. The Candidate Nomination Form must also be signed by the candidate indicating his/her acceptance of the nomination to stand for election to the Board of Trustees, and consenting to the conditions contained therein.
- 8. The duly completed and signed Candidate Nomination Form must be accompanied by a Curriculum Vitae of the candidate, together with a legible identity document sized photograph of the candidate. Certified copies of the candidate's identity document and highest qualification must also accompany the Candidate Nomination Form.
- 9. The candidate's full curriculum vitae must be submitted and shall include, at the very least, his/her personal information, academic qualifications, employment history, information relating to any current or previous directorships that he/she holds/have held. In addition, the candidate is required to provide an abridged curriculum vita of no more than 120 words which will be used to introduce successful nominees to the members. The Board of Trustees reserves the right to make such amendments to the abridged curriculum vitae as may be necessary.
- 10. All information required on the Candidate Nomination Form must be completed. Failure to do so may invalidate the nomination.
- 11. The Board of Trustees shall screen the Candidate Nomination Forms and assess the candidate's eligibility to stand for election to the Board of Trustees.
- 12. Original completed and signed Candidate Nomination Forms, together with all supporting documents must reach the Administrator, at: 7 Lutman Street, Port Elizabeth, 6000 (hand deliveries) marked clearly for the attention of: Principal Officer (Mr. G. Roberts) or be posted to P.O. Box 1672, Port Elizabeth, 6000 (postal deliveries) marked clearly for the attention of: Principal Officer (Mr. G. Roberts) The nomination forms must be RECEIVED by the Administrator at the aforementioned addresses by no later than 16h30 on 23 May 2019.
- 13. For purposes of this process, your attention is drawn to the Scheme Rules, and in particular, to the following:
  - 13.1 In terms of section 18.4 of the Scheme Rules, the following persons are not eligible to stand to be elected as a Trustee:
    - 13.1.1 A person under the age of 21
    - 13.1.2 An employee, director, officer, consultant, or contractor of the Administrator of the Scheme or of the holding company, subsidiary, joint venture or associate of that Administrator
    - 13.1.3 A broker
    - 13.1.4 The Auditor of the Scheme
